Determination of Royal Bathurst Show Protest Committee 2017/001

In regard to an official protest received by the Association alleging the incorrect award of places & prizes in Class H 35 611 (Working Hunter n.e 14hh).

Under the rules of the Bathurst Agricultural, Horticultural & Pastoral Association applicable to the conduct of the Royal Bathurst Show, an official Protest Committee (2017/001) has determined that due to an incorrect and unofficial protest in the area of adjudication during the conduct of the Class, the Stewards and Judge were placed in a position such that the award of places & prizes in the class was incorrect.

They also found that no breach of any Bathurst AH&PA or other applicable rule was identified that would lead to any exhibit being disqualified from adjudication.

Therefore the results for the Class are to be determined from the scores on the official scorecard for the class signed by the Judge, and recorded as such. The award of places and therefore prizes including ribbons, prize money and performances are confirmed as:

Exhibitors are reminded:

- that the Rules that apply to the Royal Bathurst Show are those published within the relevant schedules;
- that only the Entrant may officially withdraw an Exhibit from a class;
- that it is not appropriate to approach a Judge in the ring/area of adjudication to discuss the adjudication of a class; and
- that aggressive and intimidating behaviour towards Judges, Stewards, Officials and other exhibitors will not be tolerated.

Under General Regulation 21 of the Association this decision is final and binding.
