BATHURST REGIONAL COUNCIL FOOD VENDOR OUTLET CLASSIFICATION

Food Vendor outlets are classified by Bathurst Regional Council as High, Medium or Low risk and the fees vary accordingly.

- **Low Risk Outlets** are typically those that require minimal inspection or sell pre-packaged food, e.g. Jams & preserves, Show bags, prepackaged sweets etc or are Not-for-profit/Charitable organisations/CWA/Schools etc.
- **Medium Risk Outlets** are those such as coffee carts selling coffee only.
- **High Risk Outlets** are typically those selling take away or consumable products prepared at the event e.g. bbq's, hot chips, gozlemes, kebabs, burgers, dagwood dogs, pizzas, etc.

All outlets will be inspected by Bathurst Regional Council Inspectors for food safety compliance on a daily basis. Payment of the fee in advance is a requirement of acceptance of trading at the Show.
